# Energy Markets Access and Optimisation

In response to the increased variability in supply that accompanies the transition to renewable sources of energy generation, grid operators now place a premium on energy storage and generation assets with the ability to modify their electrical production or consumption when required.

National Grid incentivises energy storage and generation asset owners to participate in ancillary, capacity or energy market flexibility programmes. In return, the asset owner receives significant payment for providing this essential service. For example, the latest T-4 Capacity Market auction in Great Britain cleared at the record price of £65,000 per MW.

There are many value streams available for different asset classes in Great Britain and Ireland. The key to maximising the rewards available is being in the right market, at the right time.
